

INDEX PROVIDER MVIS ANNOUNCES NOVEMBER PERFORMANCE OF MARKET VECTORS HEDGE FUND BETA INDICES

Frankfurt (2 December 2013) – Market Vectors Index Solutions (MVIS) today announced the November performance for its six investable Market Vectors Hedge Fund Beta Indices. Each index is constructed using transparent, liquid ETFs to produce hedge fund-style returns without hedge fund pricing, opaqueness and redemption restrictions.

With a history stretching back to 2003, the Market Vectors Hedge Fund Beta Indices use a patented methodology in seeking to capture the beta returns of universes of statistically similar hedge funds that exhibit in aggregate consistently high concentrations of beta. MVIS currently offers four regional and two global long/short hedge fund strategies.
