

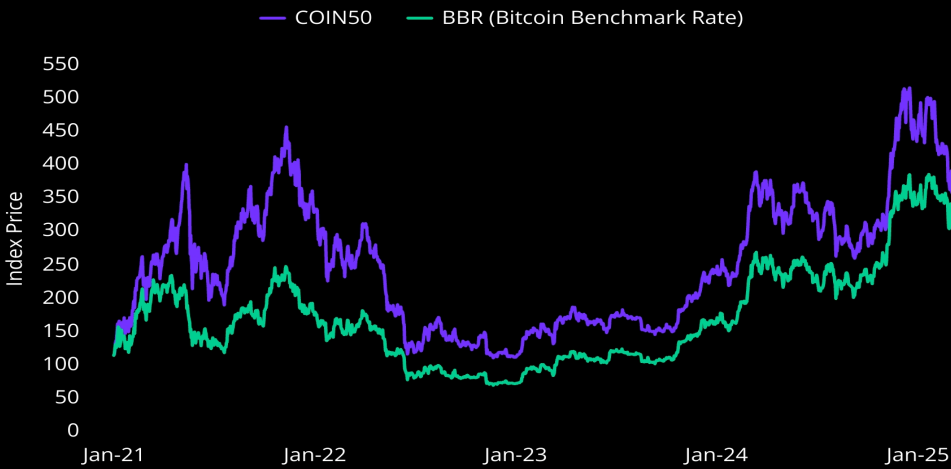
COIN50 Daily Summary

The COIN50 index posted a daily return of 0.56%. The charge was led by impressive returns from media and entertainment, meme coins, payments, and smart contract platforms sector, with the latter delivering a noteworthy return of 1.2%. On a 30-day basis, COIN50 index saw an encouraging uptrend, delivering a strong return of 17.43%. In a broader perspective, the index continued its overall robust performance over the last 90 days, generating a return of 21.08%. The day was marked by the positive performance of some tokens. ZEC stood out with a robust return of 9.06%. In contrast, the INJ token was at the other end of the spectrum, indicating a negative return of -3.45%. Other notable tokens include 1INCH, LDO, and APE, which achieved returns of 5.18%, 4.06% and 3.65% respectively. Daily Performance Summary of COIN50 Index

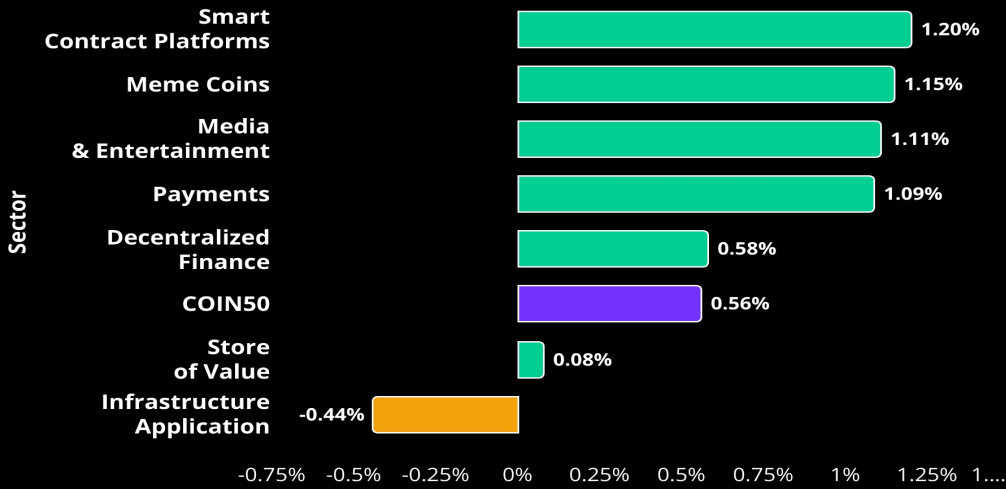
Key highlights:
