

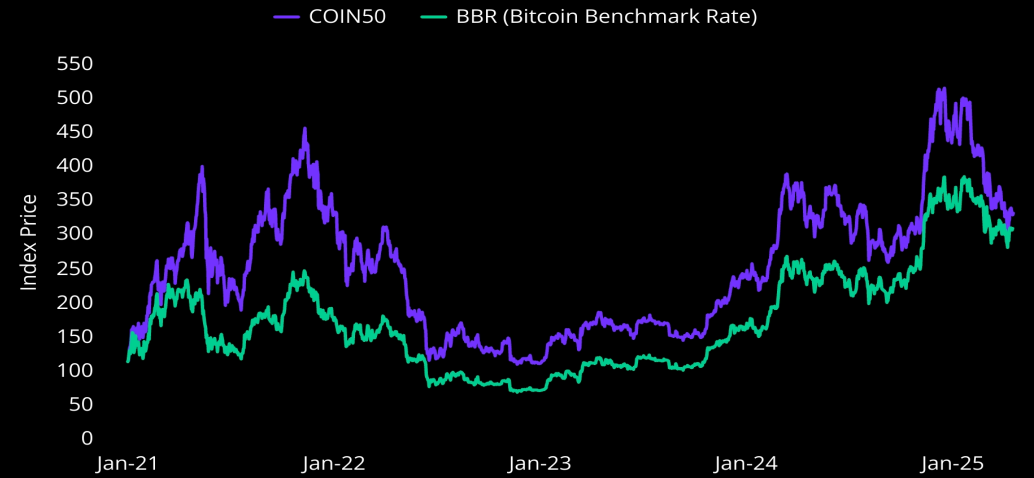
COIN50 Daily Summary

The COIN50 Index reflected a slight upward movement with a daily return of 0.89%, powered by positive returns across multiple categories. Particularly, Media and Entertainment category secured a substantial return of 5.06%. However, this small boost does not mitigate the bearish 30-day and 90-day trends, with the Index down by -8.29% and -34.27% respectively.

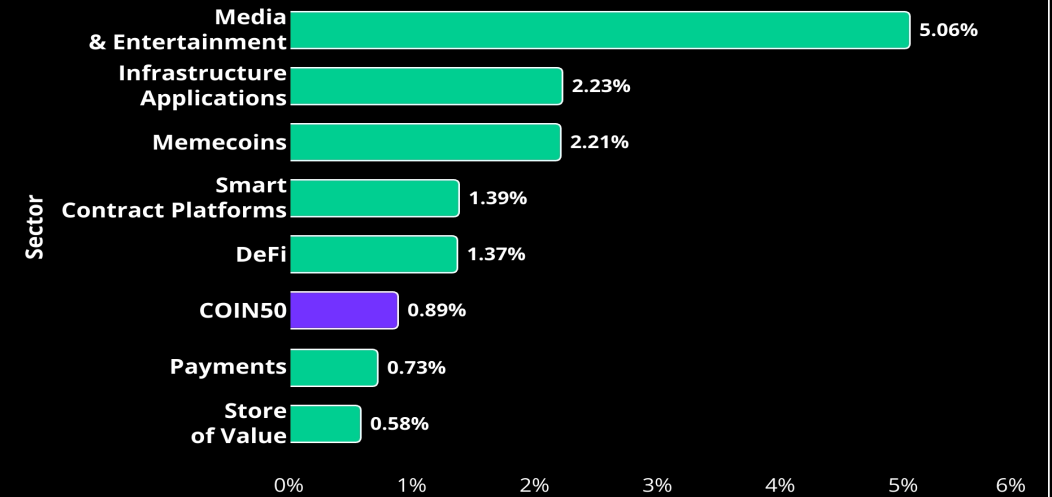
Key highlights:

- 1. Top Performer:** The ROSE token led the pack with an impressive return of 10.05% within the day indicating a robust performance.
- 2. Largest Decline:** On the flip side, QNT token was the least performer, posting a loss of -2.24%, reflecting a struggle in upward momentum.
- 3. Noteworthy Movements:** The FET, WIF and SAND tokens also showed Resilience by securing returns of 9.29%, 8.86% and 6.40% respectively, contributing to the slight upward movement in the Index. Overall, while the day witnessed some strong individual token performances, the larger trend for COIN50 remains bearish.
