

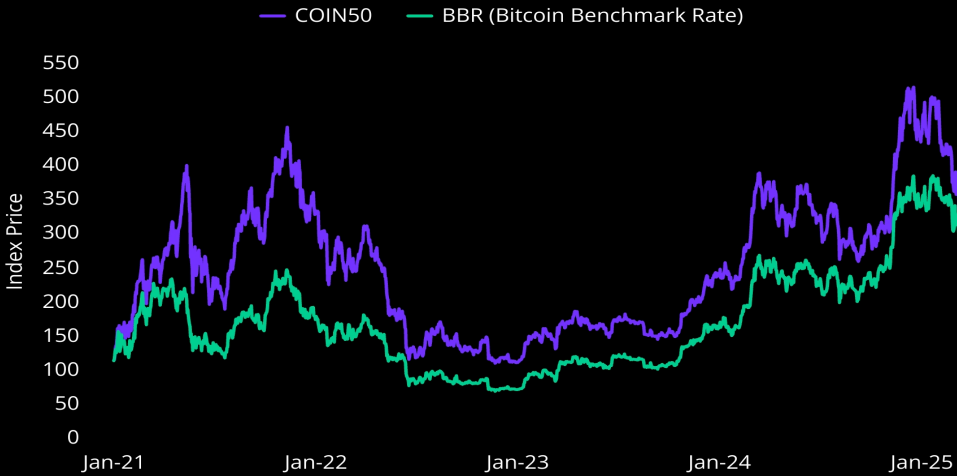
COIN50 Daily Summary

The COIN50 index showed a stellar daily return of 4.36%. Category-wise, the MEME COINS sector outperformed with a significant return of 6.9%, closely followed by INFRASTRUCTURE APPLICATIONS which garnered 4.87%. Over the last 30 days, the index has been on an upward trajectory with a large return of 28.31%, a trend that was however subdued in the previous 90-day period with a more moderate return of 3.62%.

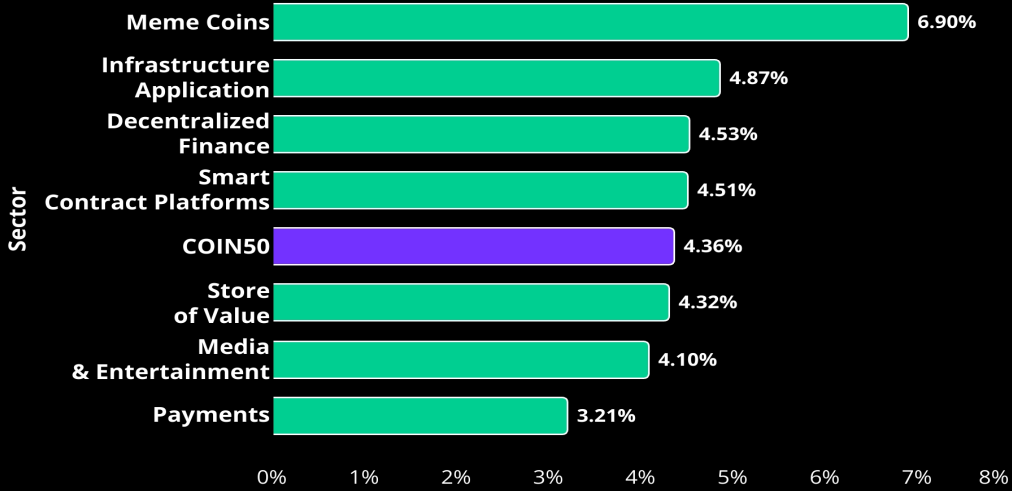
Key highlights:

1. **Top Performer:** The WIF token turned heads as the day's top performer, offering an impressive return of 12.84%, followed closely by PEPE and FET with returns of 10.76% and 10.59% respectively.
2. **Largest Decline:** On the flip side, the EOS token was on the back foot, securing the least spot in the rankings, with a negative yield of -2.64%.
3. **Noteworthy Movements:** Standout gains were also noticed from the BONK and UNI tokens with strong returns of 8.41% and 10.54% respectively, emphasizing the diversity of token performance within COIN50. This overview provides a snapshot of the COIN50 index movements, identifying key trends and performers within the diversified blend of tokens included in this index.
